LEAD RENOVATOR TRAINING PROVIDERS

Listed below are the names of approved lead renovator courses accredited ***in*** North Carolina. **The location of training is not limited to the physical address provided on this list.** In addition to offering courses at their physical facility address, most of the listed training providers are also conducting courses at various locations throughout the state depending on local demand. Since all training providers may train anywhere state-wide, you will need to check with each training provider to determine the location, dates, and cost of training.

The Health Hazards Control Unit (HHCU) also accepts courses taught ***outside*** North Carolina when the training provider and course(s) are accredited by either the US EPA or accredited by a state with a US EPA-authorized state program. Training providers offering courses in North Carolina must comply with the N.C. General Statutes §130A-453.22 - 453.31, Certification and Accreditation of Lead-Based Paint Renovation Activities and 10A N.C.A.C. 41C .0900, Lead-Based Paint Hazard Management Program for Renovation, Repair and Painting Rules. All training providers and their lead renovator courses taught for certification purposes ***in*** North Carolina must be accredited by the HHCU prior to offering such courses. Those interested in conducting training in North Carolina should contact the HHCU for additional information, forms, and applications.

Note: The HHCU does not accept online or virtual lead renovation courses.
